- The Property Owner List has been updated and given to our attorney to update on the website.
- Strategy
 - Work smaller units first
 - Time Limit is 60 days from first signature in each unit.
 - A motion was made by Bentley and seconded by Manly with an all in favor vote to approve use of Yard Signs to remind property owners to return the consent forms. Cost \$90 approx. for 5 signs that can be moved and reused
- The volunteer Committee Members need to be notified before any emails or USPS mails are issued. - assigned to Manly
- Cost Estimate for for email service, printing and USPS
 - Email by our vendor includes 10 separate distribution lists with a minimum of 2 mailings to each list. Reporting includes reporting bad emails and the quantity of emails opened. Cost \$450
 - Printing 2022 cost estimate \$2000; 2021 was \$1700
 - Will need to have a printed quantity of each of the 10 Intro Letters and 10 Consent Forms on hand.
 - Legally we are required to print and mail via USPS to all property owners who did not return a signed Consent Form.
 - We have 332 email addresses registered
 - USPS Mail Cost \$512 estimate for 200 packages

- Carryover business: (Bentley)
 - South Lake Ramp Dock
 - All American Marine is in the process of replacing the deck boards at no cost to the community. They already did the dock at the Lake Asbury ramp. Huge thank yous to this generous community contribution by Lanity Raiford and Michelle Douglas.
 - Repair/Replacement of Ramp Gate at Lake Asbury
 - Received estimate from Specialty Enterprises to repair the gate for \$2400 or to widen and replace at \$3800. Last month a motion was made to approve the replacement costs. This past month Bentley finalized plans with Specialty Enterprises and communicated with LAMSBD of the changes which includes moving the corner posts to widen the ramp by almost 2 feet and replace the gate with a cantilever gate.
 - o Election of Board Members:
 - Vote occurs in May at the Annual Meeting. Ballots are mailed in late March/early April.
 - Up for election in 2022 is Ruiz, Rankin, Russell, Bentley
 - Resigning this year is Ruiz and Rankin
 - Need volunteers from community to run for board
 - Collection of Annual Dues;
