

**LAKE ASBURY LAKE LOT OWNERS ASSOCIATION, INC.**  
**SECURITY & SAFETY RULES**

It is incumbent upon each Lake Lot Owner, family, and guest to abide by and promote lake security, safety and courtesy. **Violation of the listed rules will result in confiscation of your current key and the loss of key and lake privileges for the following year.**

1. All U.S. Coast Guard, Florida Fish & Wildlife Conservation Commission and Florida Marine Patrol rules and regulations apply on the lakes. (Available at all Clay County tag agency outlets).
2. **Observe NO WAKE ZONE in all fingers.**
3. During periods where the water is above or below normal ranges in the lakes, you are limited to IDLE SPEED to prevent wake damage to lakefront properties and dams.
4. Floating docks must be retracted to the 15 foot limit and remain out of the boating path.
5. There are no fishing tournaments/parties allowed on any of the lakes that are not sponsored by LALLOA.
6. It is a violation to loan your key to the LALLOA Boat Ramps or to allow boating access to the Lake Asbury lakes to anyone who is not a valid Full Level Member, immediate family, or your invited guest(s).
7. ALL motorized watercraft are required to carry a valid Motorized Vessel Pass while on the LA Lakes.
8. All powered watercraft are required by law to be registered and/or numbered. (Florida Boater's Guide).
9. All motorized watercraft should carry Liability Insurance when on the lakes of Lake Asbury.
10. Two (2) motorized watercraft (boats, jet skis, etc.) per Lakelot Owner is allowed on the lake at any one time.
11. All powered watercraft must travel in a counter-clockwise direction, even when picking up a skier, knee-boarder, etc.
12. No abusive/foul language or dangerous/reckless behavior on the lakes
13. When leaving the ramps, remember to close and lock gates. Report any damage to the gates to LALLOA.
14. Per Florida Law, operators of a personal watercraft must be fourteen (14) years of age. Persons born on or after Jan 1, 1988, must complete a NABLA (National Association of State Boating Law Administrators) approved boater safety educational course prior to operating a power vessel greater than 10 horsepower.
15. All skiers and personal watercraft operators are required by law to wear U.S. Coast Guard approved personal flotation devices. Florida state law states that waterskiing is prohibited from one-half hour after sunset to one-half hour before sunrise. When towing a skier, knee-boarder, wake-boarder, or tube, there must always be at least two people in or on your powered watercraft or such craft must be equipped with a wide-angle rearview mirror. Raise a red flag or your hand when your skier, knee-boarder, etc. is down or if you see that another is down. Skiers, knee-boarders, etc., must stay 30 feet away from the shore or structures, including those at the face of each dam. (Florida Boater's Guide.)
16. Powered watercraft must maintain a safe distance from skiers, knee-boarders, etc. and other watercraft. (Florida Boater's Guide.) Swimmers must not swim or float in power watercraft traffic pattern.
17. Florida has very strict laws on operating a vessel while under the influence of alcohol and drugs. The law makes it crystal clear that alcohol or drug-impaired power water crafting is a crime. (FL Boater's Guide.)
18. Issues involving reporting of boating safety violations (speeding, recklessness, creating large damaging wakes) call Clay County Non-Emergency line (904) 264-6512 requesting Marine Officer contact. To report nuisance alligators, contact SNAPs (Florida Statewide Nuisance Alligator Program) at 866-392-4286 between 8am and 5pm 7 days a week. **If there is an emergency call 911.** LALLOA -- Lakeasbury.net
