Insurance

- Insurance is up for renewal. Kay is awaiting quotes from 3 separate agencies at this time. There has been a zero-loss ratio since 2018; however, insurance in FL has become more challenging to obtain.

 - Annual LALLOA Meeting need to plan this meeting need a speaker. Mike recommended FWC – Debbie will take the lead.
 - Boat and Safety Course another idea for a community activity
 - Weed Removal Larry Pence advised there will be a company working on hyacinth and weed removal in the North and South lakes for 15 working days – contract with Solitude, a water management company. The cost per year divided by the number of homes equals \$4 per month per person. If there are good results, they will determine if the contract will be extended for grasses / weeds. The long-term contract will also include Lake Ryan if warranted. If there is any down time on the machine, the company will work into the weekend to ensure we have 15 actual working days. There is a need to identify places to put the weeds / grasses temporarily if anyone has the ability to provide a location.
